- Citation is different for Law reports (cases) before 2002
- From 2002, cases have been given a neutral citation that identifies the case without
  referring to the printed law report series in which the case was published. This helps
  to identify the case online. For example, through the freely available transcripts of the
  British and Irish Legal Information Institute (www.bailii.org) and databases including
  Westlaw and LexisLibrary.
- If you are using the neutral citation, also provide the publication in which the case was reported or the database or website that you used.

#### **Notes**

- Title of legislation should be cited exactly, capitalisation unaltered regardless of the referencing style.
- First reference to an Act or Statutory Rule should be cited with their short formal title, in italics (*title*), exactly and in full. In subsequent references, title can be in **roman type** (not italicised) and date omitted.
- Titles of Acts of the parliaments of other countries should be presented in roman type (not italicised), e.g. Therapeutic Goods Act 1989 (Australia).
- Acts should be referenced as if in print even if viewed electronically.
- When citing a reference to a Section of an Act, the abbreviations 's.' and 'ss.' can be used, though they should never start a sentence.
